Rationale – Closed Facebook Group ‘Epping North OSHCP Families’

The main purpose of the Closed Facebook Group is to provide an additional communication tool for the educators and administrators of Epping North OSHCP Families

The group will be used to share information that is already provided elsewhere via email, the Epping North OSHCP website or in note form. This will include:

- recent updates to centre policies or procedures;
- centre improvements;
- calendar events;
- vacation care programs;
- weekly and/or daily updates and reminders such as SMASH excursions;
- weekly or daily menus
- ad hoc communications, as needed.

Our Facebook group will allow our members to keep up to date with activities through a medium preferred by many.

Rationale – Public Facebook Page – Epping North OSHCP

The main purpose of the public Facebook Page is to publicly raise awareness of the centre, share information about the centre and raise the centres brand within the wider community. This will include:

- photos of children and activities,
- cultural celebrations,
- interviews with members of the centre,
- history of the centre and school,
- our philosophy and pedagogy.

Policy Statement

ENOSHCP will use Facebook as a communication platform. ENOSHCP reserves the right to suspend or cease using Facebook at its discretion. Where there are issues of a potentially serious or criminal nature such as threats or inappropriate comments, the matter will be referred directly to the relevant authorities.

Procedure

Membership

Epping North OSHCP Facebook group is a “Closed Group” community. This means that individuals who are recognised as parents, caregivers or guardians of children attending the centre will be invited to join the Facebook group and will form part of the “Membership” or “Members”.

Membership will be approved or renewed on an annual basis at the beginning of each school year or as soon as new members and their children join the centre.

Members whose children have left the school and are no longer financial members of the centre will be deactivated from the group at the end of the school year. Members can request to re-join at a later time when they become financial members of Epping North OSHCP again.

Parents, caregivers, and guardians of children at the centre also have the right to abstain from joining the group when invited. All essential information about enrolments, programs and governance will still be communicated to parents and guardians via email or through the Epping North OSHCP website www.eppingnorthoshc.com.au/

The Epping North OSHCP Facebook Page is open to the public for members of the community to gain an insight to what happens at the centre. Information, photos, interviews and marketable information about the centre will be posted to the public whilst ensuring photos of children are not posted unless permission is sought prior.

Administrators and Moderators

Epping North OSHCP Facebook group will be administered primarily by the Centre Director and Assistant Director. For operational reasons, both these roles will post on the Facebook group under a pseudonym “Blake Turner”, and under the Epping North OSHCP page name.

To assist with sharing relevant information in a timely manner, additional posts, calendar events and general moderation duties will be performed by members of the Epping North OSHCP parent committee, who have children attending the centre. Administrators and moderators have sole discretion to remove a post or a member if they breach this policy.

Privacy

All members interacting with the Epping North OSHCP Facebook group, by either liking or commenting on posts, must do so using a Facebook account that clearly identifies them by their real name.

No identifiable photos of children will be posted on Facebook without prior consent of the parents.

Member posts on the Facebook Group

Initially, members will be able to comment on the Epping North OSHCP's posts and on comments by other users. Members will also be able to 'like' a post or make a comment when a comment function has been enabled. Members may not load media such as video or photos. Member rights will be reviewed over time and as part of a formal evaluation process.

Personal Disclosures

If you have personal concerns or are worried about something relating to your child or yourself, contact the Centre Director or Assistant Director as soon as possible.

Please do not post personal or urgent issues on the Epping North OSHCP Facebook Group.

Raising Issues & Making Suggestions

Epping North OSHCP Facebook group is not a platform for raising issues concerning own children, other children or staff working at the centre. All issues need to be raised directly and privately with the Centre Director or the Assistant Director.

Suggestions of a general nature are welcome, for example an excursion idea or an activity the children would enjoy. If you want to make a suggestion for improvement or something that needs to be enacted urgently, please email the Centre Director or Assistant Director or make an appointment to discuss.

Using Names in Posts

Members can use names in posts when you wish to acknowledge someone's great work or contribution. You can tag another member to alert them to a particular post or event.

Underage Facebook Users

Epping North OSHCP does not endorse children, under 13 years of age (a threshold imposed by Facebook), creating their own Facebook account. Children known to be under the age of 13 will not be given membership access to the group.

Cyber safety

E-security and personal online safety precautions are the responsibility of every member, and all users should have a personalised safety action plan. All users including centre staff, administrators and moderators and parent members of the ENOSHCP Facebook Group should take reasonable safety precautions when accessing information or posting comments. Users must not publish identifiable images of children, and images of centre staff or other members must have permission

to do so. We encourage all users to check their own Facebook privacy settings and take responsibility for the information that they publish on their Facebook accounts.
